AGREEMENT on confidentiality of data constituting commercial and other secrets protected by law

- I, "Client", being a participant of the Qazaq Green Certificate Registry of ALE Association of RES "Qazaq Green" (hereinafter referred to as "the Association") on ensuring the confidentiality of information and documentation received and made known to me on the following conditions:
- 1. I agree to keep commercial, financial and other interests in good faith, not to disclose and not to transfer to the third party any information obtained in the course of joint work, except for cases when it is done with the written consent of the Association, or the list of information allowed for disclosure is determined by a special written agreement of the Parties.
 - 2. Confidential information shall include, (but not limited to):
- 1) circumstances that have a business relation to the financial or economic activities of the Parties;
- 2) names of governmental bodies, financial companies, banks, fiduciaries, investors, sources of crediting, guaranteeing and securing obligations, attorneys, customers, including names and other personal data of officials involved in the subject of relations;
- 3) any other information recognized as confidential by the legislation of the Republic of Kazakhstan.
- 3. Obligations on non-disclosure of confidential information shall be imposed on the Client. Information may not be confidential if access to it is free in accordance with the legislation of the Republic of Kazakhstan.
- 4. Disclosure of confidential information is a violation and may entail unilateral termination of contractual relations between the Client and the Association, regardless of whether it is caused by deliberate, reckless or arrogant actions of the Client.
- 5. All disputes and disagreements related to the violation of this agreement by the Client will be resolved through negotiations. In case the Parties fail to reach a mutual agreement as a result of negotiations, all disputes and disagreements shall be finally settled in court, according to the current legislation of the Republic of Kazakhstan.

AGREEMENT TO COLLECT AND PROCESS PERSONAL DATA

- I, "Client", being a member of the Qazaq Green Certificate Registry of the ALE Association of RES "Qazaq Green" (hereinafter referred to as "the Association") to collect and process by the Association (including receiving from me and/or from any third parties) my personal data to the extent necessary for:
- to conclude with the Association any contracts, annexes, additional agreements thereto and other documents aimed at rendering services to me;
- to make decisions or take other actions with legal consequences for me or other persons;
 - to provide me with information about the services rendered by the Association;
- for interaction between the Association and third parties that are and (or) may be related to the conclusion and (or) execution of any transactions/operations concluded between me and the Association;
- to provide reports and (or) information to authorized bodies, audit and other competent organizations, state bodies;
- for other purposes which are (might be) established by the legislation of the Republic of Kazakhstan or arise from the substance of contracts/agreements concluded between the Association and me.

This consent to the collection and processing of personal data shall not be revoked in cases where it is contrary to the laws of the Republic of Kazakhstan, or in the presence of unfulfilled obligations to the Association.

This consent grants the Association the right, in the manner prescribed by the laws of the Republic of Kazakhstan, to perform any action (operation) or a set of such actions (operations) with personal data, including, but not limited to, collection, processing, recording, copying, systematization, accumulation, clarification (modification and supplementation), use, distribution, depersonalization, blocking, deletion, destruction, as well as any other actions taking into account the requirements of the current legislation of the Republic of Kazakhstan.

At the same time, I confirm that by giving such consent, I am acting of my own free will and in my own interests, and I also recognize and confirm that this consent is considered as data for transfer of my personal data to third parties who have the right to process personal data on the basis of this consent, provided that the requirements of the Law of the Republic of Kazakhstan "On Personal Data and Their Protection" are met.

AGREEMENT ON COMBATING PRIVATE AND PUBLIC SECTOR CORRUPTION, MONEY LAUNDERING AND TERRORIST FINANCING

1. I, "Client", being a participant of the Qazaq Green Certificate Registry, hereby give my consent to the Association of RES "Qazaq Green" (hereinafter - the Association) that I will not allow in connection with my participation in the registry to commit an act (action or inaction) directed against the interests of service in commercial and other organizations, the interests of public service and public administration protected by the current legislation of the Republic of Kazakhstan.

Such acts include abuse of authority, commercial bribery, bribe-taking, bribe-giving, mediation in bribery, dishonest attitude to duties.

- 2. I represent and warrant to the Association that I have not performed the acts set forth in paragraph 1 of this Consent for the purpose of establishing and/or extending any business relationship with another party or the Association.
- 3. I acknowledge and agree that I have familiarized myself with the legislation on combating corruption in the private and public sector, anti-money laundering and terrorism financing of the states in which it is established or registered and in which it operates, and undertake to comply with it (the Law of the Republic of Kazakhstan "On Combating Legalization (Laundering) of Proceeds of Crime and Terrorism Financing").
- 4. I agree that I will not commit and will not permit with my knowledge the commission of acts for which liability is provided by the legislation on combating corruption in the private and public sector, anti-money laundering and countering the financing of terrorism.
- 5. I agree that my accounting records are kept in accordance with the current legislation on accounting and financial reporting, fully and accurately reflect all payments made under contractual relations.
- 6. If I become aware of an actual or suspected violation by me of any of these provisions on countering offenses against the interests of service in commercial and other organizations, the interests of public service and public administration, I shall immediately inform the Association thereof and assist in verifying this information.
- 7. I undertake to ensure the implementation of procedures to prevent the facts of corruption in the private and public sector within the framework of this Consent.
